These foreclosed or abandoned properties will be renovated and made available for purchase by low to moderate income families.

In addition, twenty-eight Union County families are now first-time homeowners as a result of the Down Payment Assistance Program administered by FBM.

Although a small non-profit organization, Faith, Bricks & Mortar has played a great role in providing housing assistance in Plainfield and greater Union County. We need your support to continue this great work.
